ENTRIES: \$25 FIRST TEST. \$20 each extra test on same horse.
NO REFUNDS AFTER THE CLOSING DATE.
SUB. of horse or rider **CAN BE MADE** in the **SAME TEST**.

POST ENTRIES: If space permits. \$5 extra per horse if entry fees are not received by the secretary **BY** the closing date.

SCHEDULE: Will be mailed to each rider the week of the show.
Check your schedule for arena size. (see info. below)

ARENAS: 70' x 156' covered warmup and 113' x 215' outdoor arena, both with sand and wood chip footing.
EVERY ATTEMPT will be made to use the standard (long) outdoor arena for tests if footing is dry enough.
EXCEPTION: In early shows (Mar-Apr-May) we may use the outdoor arena (113' x215') for warmup and the indoor for tests (20x40m) to protect the outdoor footing. LUNGING in fields only.
IN LATER SHOWS this could occur due to severe rain.

RULES: USEF rules will be followed. Jackets are not required, but riders must wear boots with heels, breeches, and **IT IS REQUIRED THAT RIDERS WEAR PROTECTIVE HEADGEAR with chin strap AT ALL TIMES WHEN MOUNTED. NO EXCEPTIONS.**

AWARDS: Prizes to 1st place and Ribbons to 5 places.

CLASSES: PLEASE STATE CLEARLY which tests you enter. We will arrange them into classes based on the number of entries.
